OF APPLICABILITY TO USHPA CHAPTER

*Flight under FAA Regulation "Part 103 is based on the assumption that any individual who elects to fly an ultralight vehicle has assessed the dangers involved and assumes personal responsibility for his/her safety". FAA AC-103-7*

In consideration of being allowed to use the facilities and participate in the sport of "Ultralight Vehicles" and other activities (collectively the "Activities") provided by Storm Peak Hang Gliding, Inc. (the "USHPA Chapter"), I hereby reaffirm the United States Hang Gliding And Paragliding Association ("USHPA") Release, Waiver and Assumption of Risk Agreement (the "USHPA Release") previously signed by me and acknowledge that it is applicable to my participation in any and all Activities of the USHPA Chapter. Each of the terms, including the definitions, of the USHPA Release are hereby incorporated by reference as though fully set forth in this affirmation. I specifically acknowledge that the following persons, including their owners, officers, directors, managers, agents, spouses, employees, officials (elected or otherwise), members, independent contractors, sub-contractors, lessors and lessees, are also RELEASED PARTIES as that term is used in the USHPA Release:

This specification of certain RELEASED PARTIES is not meant to be an all-inclusive list or to limit in any way the scope of persons included within the definition of RELEASED PARTIES in the USHPA Release. Rather, it is made to give assurance to those listed here that they are included within the scope of the definition of RELEASED PARTIES in the USHPA Release. "Ultralight Vehicles" includes powered and unpowered hang gliders and paragliders. Mini-wings and speed-wings are types of paragliders.

This affirmation in no way limits, restricts or narrows the terms or scope of the USHPA Release previously signed by me.

In addition, I specifically here recognize that hang gliding and paragliding are potentially dangerous activities and that by engaging in hang gliding or paragliding activities, I could suffer injury and/or death. **I hereby acknowledge that I will take full responsibility for and hereby waive any and all claims for my death or any injury, damage or loss that I may suffer while on or above any property used, operated, managed, accessed or insured by the Storm Peak Hang Gliding, Inc. ("SPHG"), or any other property where I may engage in any**

**hang gliding or paragliding related activity. I further waive any and all claims and legal rights of any kind which I may have related to any accident, death, injury, damage or loss I may suffer as a result of engaging in any hang gliding or paragliding related activity on or above any of those properties, whether or not such accident, death, injury, damage or loss is due, in whole or in part, to the negligence or intentional act of any person or entity. I further agree to defend and indemnify the SPHG and its insurance companies, successors in interest, commercial and corporate sponsors, agents, employees, representatives, assignees, officers, directors, and shareholders (each a “Released Party”) for any and all claims by a third party arising in whole or in part from my participation in hang gliding or paragliding activities. I agree to pay all costs and attorney’s fees incurred by each Released Party in defending a claim or suit brought by a third party arising in whole or in part from my participation in hang gliding or paragliding activities. I further acknowledge and agree that the foregoing waivers and indemnity shall be binding on my heirs, survivors, successors, personal representatives, and estate.**

I have read, understand and will comply with the SPHG site rules and equipment requirements. I hereby acknowledge and agree that in order to pilot a hang glider or to kite or pilot a paraglider at any SPHG insured site, I must and shall be a current member of USHPA with an appropriate rating for the site and the activity that I am engaged in. Furthermore, I understand that to be a member of the SPHG, I must and shall also be a current USHPA member and a rated pilot of the aircraft that I pilot. I, therefore, hereby acknowledge and agree that I shall not kite or pilot a hang glider or paraglider on or above any of the properties identified above unless I have a current SPHG membership, a current USHPA membership, and an appropriate rating with SPHG approval for the site and the activity I am engaged in. I hereby acknowledge and agree that this document constitutes a full waiver of my rights as stated and I hereby affirm and agree that neither I nor any other person or entity on my behalf, shall initiate or pursue any legal remedy against any property owner, SPHG or its directors or officers, USHPA, or any other person or entity against whom claims have been waived by this document.

I further acknowledge and agree that this document shall not be deemed to limit, amend or revoke any waiver or release that I have granted or that I may grant hereafter to any property owner, person or entity.
